# Glossary of Terms

## Application Fee

The fee applicable to assess your application submission and provide feedback on activity suitability to your applied location. This is a non-refundable fee that applies to all venue hire, filming & photography applications.

## Event Deposit

For large scale events that involve multiple stakeholder engagement, a \$550 non-refundable deposit is required at the time of application. Once the event is confirmed this fee will be paid against your final venue hire costs.

## Standard Venue

All venues that are not listed in the following premium or price on application venues sections.

## Premium Venues

**Darling Harbour** - Convention Centre Forecourt

**The Rocks & Circular Quay** - Western Circular Quay Promenade, Tallawoladah Lawn, Campbells Cove, Hickson Road Reserve

## Price on Application Venues

**Darling Harbour** - Tumbalong Park, Cockle Bay

**The Rocks & Circular Quay** - First Fleet Park

## Commercial

Commercial organisations and brands.

## Community

Includes registered charity and not for profit organisations. The charity or not for profit organisation must be the applicant, invoiced and licenced party to be eligible for this category.

## Public access

No engagement with members of the public. Members of the public can still use and access a significant amount of the venue space. No branding allowed.

e.g team building activity using a space without branding

## Public access – promotion

Engaging with members of the public. Members of the public can still use and access a significant amount of the venue space. Branding is allowed. E.g promoting a brand such as

product sampling activities

## Private Event

Ticketed. Invited guests. Event villages. Use of venue space that significantly reduces available venue space for general public use.

## Walks & Runs - Course Route

Walking and running event course routes that impact on the public domain areas of our precincts. Precincts are identified as follows for locations that are managed by PM NSW.

**Precinct 1** - Darling Harbour & Pyrmont locations

**Precinct 2** - The Rocks & Circular Quay

If you cross over both precinct 1 & 2 then 2 x course route fees would be applicable

## Water Shows

Fireworks and other water based display shows.

## Media Calls

### Low impact

No infrastructure. Media only invited. Using the venue only if available when you turn up to the site, there will be no venue hold for this activity. *Apply under Filming and Photography application*

### Medium impact

With some infrastructure such as stages, vehicles, marquees. Media only invited. *Apply under Outdoor Venue Hire application*

### High impact

With extensive infrastructure such as stages, vehicles, marquees and/or members of the public invited or engaged. Media invited. *Apply under Outdoor Venue Hire application*

## Ceremonies

Minimal set up as outlined in the ceremony application form 'open space conditions of use for a ceremony'. Members of the public still have access to the venue. Maximum of 3 hour booking for set up, ceremony and removal of items.
